Directions: PARKWAY (NORTH): Exit 137 - at the end of the ramp, make a left (at the light) onto Westfield Avenue (Rt. 28 East). Continue on Westfield Avenue until it ends at Broad Street. Make a right onto Broad Street. Go under the arches (train tracks). At the 6th light, make a left onto Pearl Street (Landmark: St. Elizabeth Hospital). The Main Complex is on the right, just after the bend in the road. You will first come to the Administration Building. Dwyer House is at the 1st light, to the right (on Pearl Street). Dunn Sports Center is just after Dwyer House.

PARKWAY (SOUTH): Exit 140A to 82 East (Morris Avenue) - take Morris Avenue until it ends at the Broad Street arches (railroad overpass).
